1. About CQRS Local and its Benefits

What is CQRS Local?

CQRS Local is a web based system to manage payments for local incentive schemes – very much like the national version but with you in the driving seat!

The system will allow Commissioner's to set up and manage schemes – from a simple item of service option, to a complex weighted scheme; offer these schemes out to GP practices who then submit claims for payment; The Commissioning Organisation validate these claims and authorise payment and payment is made – simple and straightforward and all within a single system.

CQRS Local aims to:

- Provide flexibility in managing local incentives schemes through a payment tool that leads to prompt payments.
- Be a one-stop-solution for providers and Commissioners to claim and manage locally driven schemes that reflect local alities.
- Make payments without the need for practices to submit invoices following the approval of a claim.
- Offer reporting tools that enable ease in monitoring activity.
- Reduce the risk of inaccurate claims.
- Make it easier for providers to understand what payments have been made against the activities claimed.

Key Benefits for a Commissioning Organisation:

- A single, central point of access.
- Easily tracked and auditable data submissions.
- A reduction in time spent developing and administrating the local payment via spreadsheets.
- A standard and consistent approach to system configuration and administration.
- Integrated, seamless participation management .
- Increased reporting functionality .
- Access to external system support teams.
- Easier integration with other Commissioning Organisations, if required, in future.

Key Benefits for a General Practice (Service Provider):

- A reduction in the administrative overhead of submitting excel based claims
- Easier reconciliation of payment
- The ability to track all stages of the process following submission
- Enhanced reporting capability


2. GP Practice Sign-up Process

The below processes will assist Service Providers with gaining access to CQRS Local depending on your chosen approval level set up.

1. The CQRS Local Team will set up a Commissioner as an Commissioning Account Administrator, who can set other users up at their Commissioning Organisation. These other roles could be; Commissioning User (tier 1), Commissioning Approver (tier 2) or Commissioning Finance.
2. A Commissioner will then email out a [registration link to](#) their GP practices' requesting for them to register for a CQRS Local account.
3. Each person at the practice who will be using CQRS Local will [register](#) for an account providing this has been agreed by their Practice Manager.
4. The Commissioning Account Administrator will receive notification of this request and will approve the account.
5. Once approved, an automated email will be sent to the Practice User who will click on a link and follow the on-screen instructions for account activation.

3. The End to End Process

This shows the end to end process in 3 steps. Please note that a GP practice will only ever see a service that they have signed up to and where this has been offered to them.

Step 1 – Commissioner creates a service, adds the service components and offers the service out to the Service Provider (s)

Step 2 – Service Provider prepares and submits Declaration*

Step 3 – Commissioner Approval Process

a) - Tier 1 Commissioner User – Inspecting the Claim

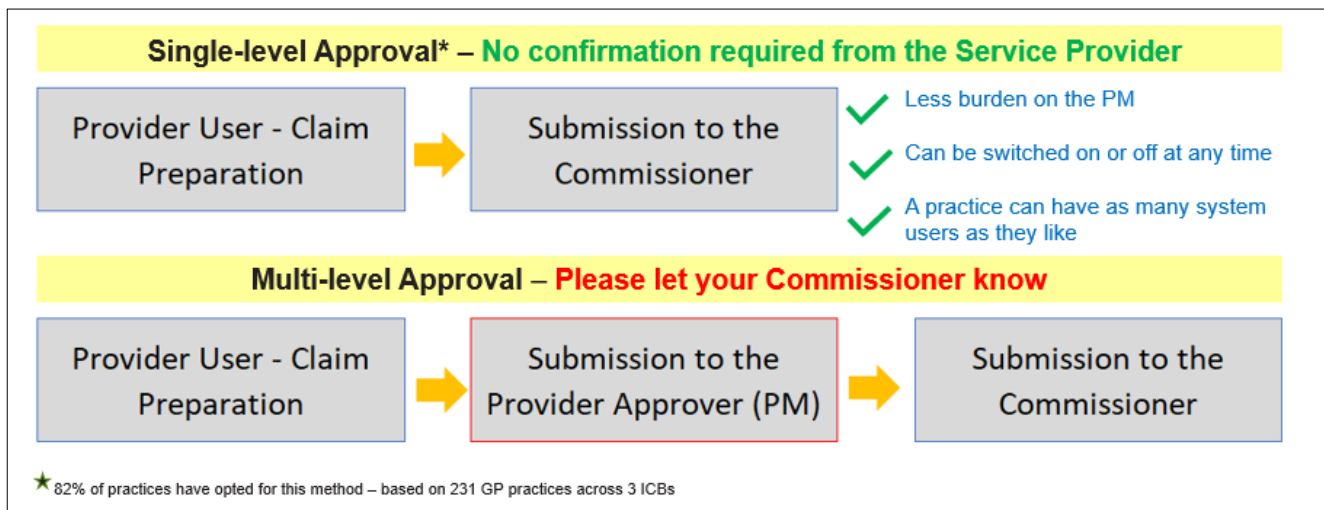
b) - Tier 2 Commissioner Approver – Approving the Claim for Payment

4. Single and Multi-Level Practices Explained

Some Service Providers currently have a single-level approval process and others have opted for multi-level approval. A single level process enables a Practice User to input achievement data and submit this themselves for Commissioning Organisation approval. These are usually smaller practices. Other organisations may prefer to opt for a multi-level approval process which will involve the claim being internally approved by the Practice or Business Manager prior to submission to the Commissioning Organisation.

The process below will show you the steps involved from beginning to end covering both the Commissioning Organisation and the Service Provider when submitting claims. This covers both a high level and low level process view.



5. User Roles and Accountabilities

Each Commissioning organisation and GP practice have a System Administrator/Super User who will create an account and give the necessary permissions depending on the users' role and job accountabilities. The home screen for example may have fewer options than a co-worker.

For enquiries relating to user roles please consult your System Administrator/Super User in your organisation.

Below are two tables covering the roles available within CQRS Local and the typical permissions which can be carried out with that level of access. This can be configured.

* If a claim exceeds an internally agreed amount, a Tier2 Approver can submit the claim to a Finance User for them to approve.

This is optional and dependant on the organisations' policies. Tier2 can still proceed and approve the claim if, for example, they had verbal approval.

6. Logging into CQRS Local & Forgotten Password

CQRS Local is a secure site and can be accessed from any web browser, such as Microsoft Edge, Internet Explorer, Chrome, or Firefox and does not need a VPN connection. Formally called N3, it will not require The Health and Social Care Network (HSCN) for a connection either.

Any user who wishes to register for an account should click on the link and follow the below instructions.



1. Click on the Register button where you will then be directed to the Registration page.
2. Enter in your email address.
3. Next is to enter in your ODS code (Organisation Data Service). If this is something you are unsure of, you can type in the name of the GP practice into the Organisation field.
4. Once you have done this, click on the Next button.
5. Now select the role you will undertake followed by your first and last name.
6. Finally, click on the Register button. Once your request is approved you will receive an email to confirm your account.


Please always ensure that you follow the password guidelines and remember to keep this password safe and not to disclose it to anybody – it's your ID and your responsibility.

Password guidelines: Passwords must be at least 8 characters and contain all of the following: upper case (A-Z), lower case (a-z), number (0-9) and special character (e.g. !@#\$%^&*)

There is an option in the log in screen which will allow you to tick to 'Remember Me'. Do not use this option if you are logging onto a shared (public) computer.



If you have forgotten your password, click on the [Forgotten Password](#) link. You will be presented with the following screen. Enter the email address that your account was registered with and click on the **Submit** button. When you receive your email from CQRS Local, follow the steps outlined.

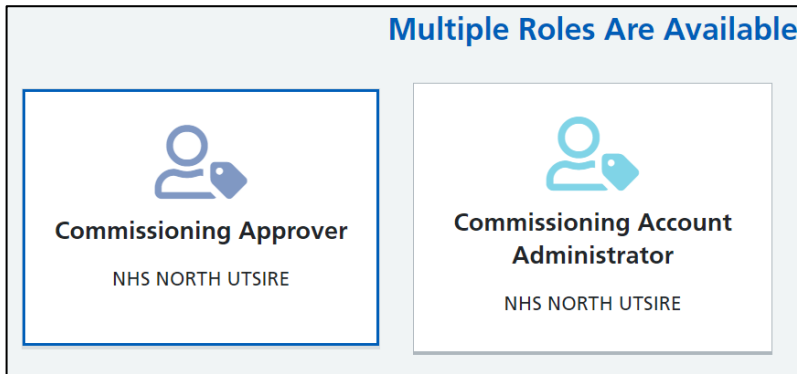

7. Switching Roles within CQRS Local

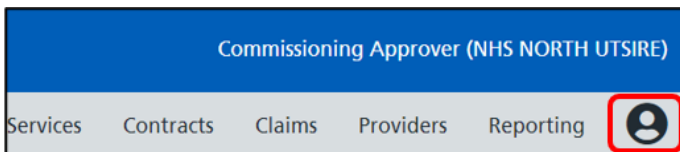
This is a convenient facility for users who have more than one CQRS Local user account to switch roles without the need to have multiple logins. Some Commissioning users for example will be set up as both the Commissioner Approver and Administrator. The following instructions will show you how you can easily switch between accounts.

Once you have entered your user name, password and logged into CQRS Local, you will be presented with a screen similar to the one shown below. Simply click on the account that you wish to use. You will then be taken straight to your homepage.



If you are already logged in as one role, i.e. Commissioner Approver, and you wanted to switch to your Admin role, then you will need to do the following:

1. Click on your **profile** icon



2. Next is to click on **Switch Role**.

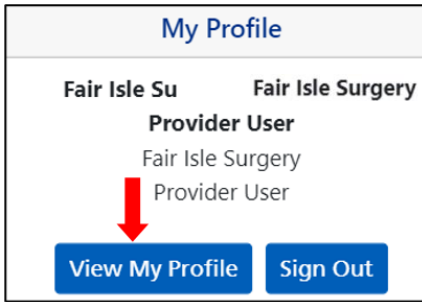
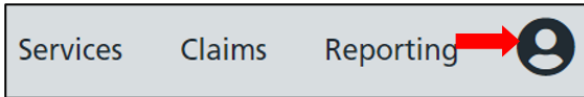


3. You will then be asked to select your account (see image above showing both roles). After you have done this, you will then be taken straight to your CQRS Local homepage.

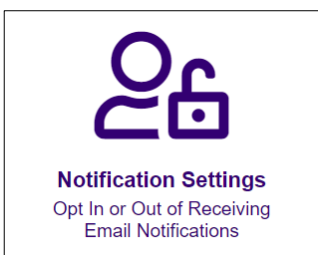
8. Stopping/Setting up Email Notifications

To set up or stop email notifications, please follow the below process.

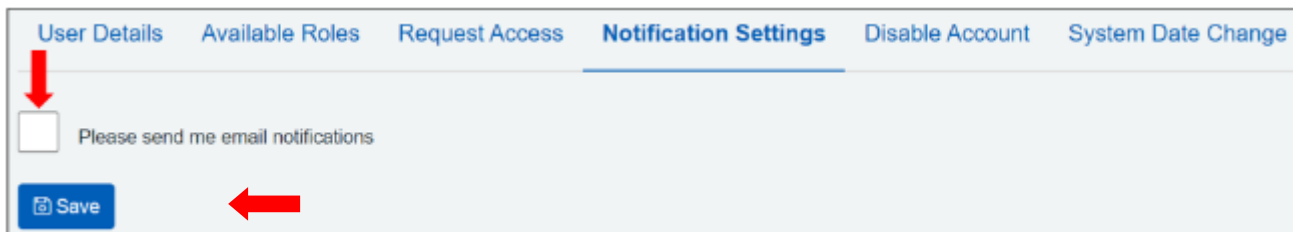
1. Click on the **View My Profile** icon located at the very right upper part of your screen.

3. Click on the **Notification Settings** menu tile.

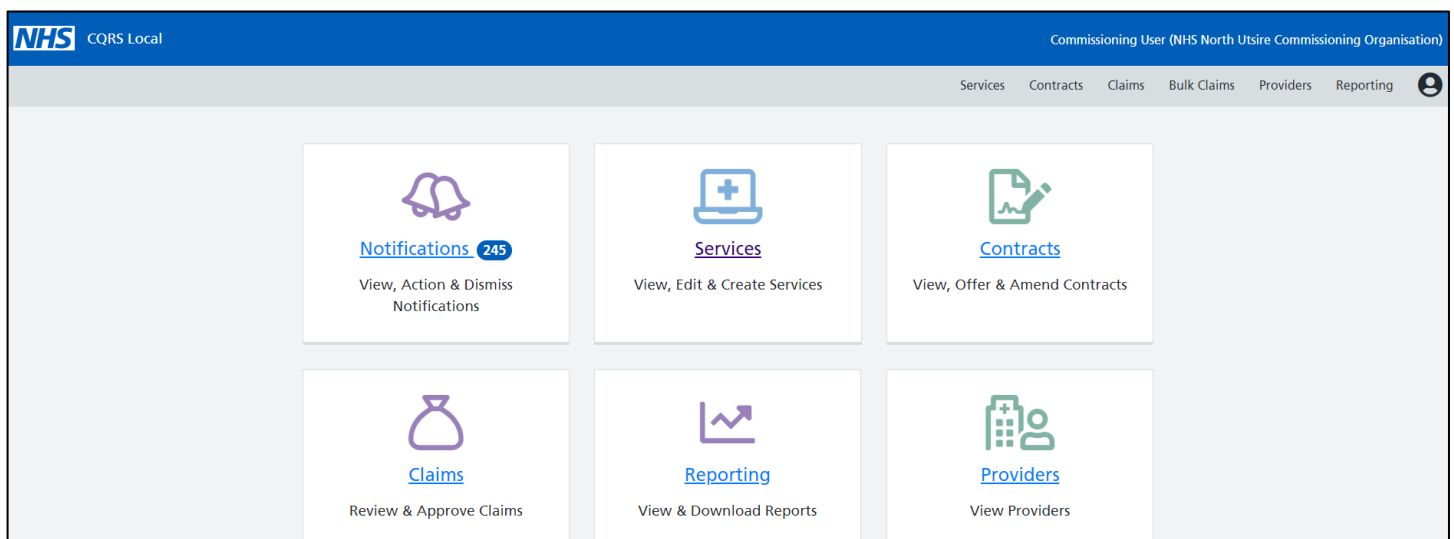


4. Tick or untick the send me notifications option.

9. Your CQRS Local Home Screen

When you log in to CQRS Local you will be presented with your home screen. Again, as mentioned previously, you may not have visibility of all the below functions.



The screen features a number of menu tiles and will take you directly to that particular section in the system. Each of the tiles are linked to the options on your menu bar.

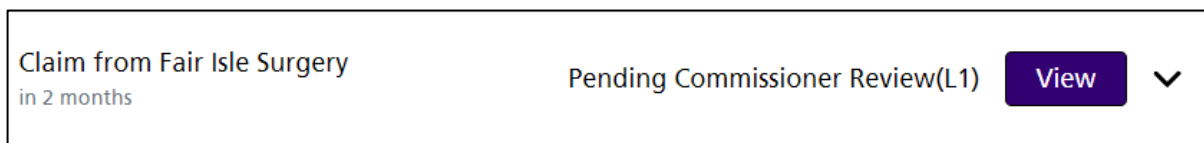


A number in a green box as shown below in Notifications, indicates that there are a total of 10 notifications for you to be aware of. Clicking on the menu tile will open the message centre. Messages in blue indicate that they have not been read. Your role and system set up will determine the type of messages that you will see. For example, an Approver will have notifications advising them that there are claims that need their approval.

10. Switching On/Off Multi-level Approval

By default, all GP practices are set to be a single level approving practice (for further information on this, please refer to the section [The End to End Process – High and Low Level View](#))

1. From your CQRS Local homepage, click on the **Providers** menu tile.
2. Locate your GP practice and click on the **View** button.
3. Tick or untick the Multi-level approval box.
4. Click **Save**.

11. Tariff Currency and Bandings

This section will aid you with deciding which tariff currency is right for your service as well as useful information relating to bandings and how they work.

	Tariff	Meaning
1	Per Unit	Per Patient or Per Test
2	Retainer	Retainer is that you will deliver a service no matter how many patients you see. A Commissioner may ask for evidence to be provided of tests completed. There may be a certain number for the Commissioner to honour payment. These are usually payable yearly.
3	Actual Population Per Item	Similar to 4 - but per Patient or Per Test
4	Actual Population Retainer	Actual Population retainer – this would usually be a small amount often circa £1 per patient paid over the year and often split quarterly (i.e. if £1 per head per 10000 patients then they would be paid £2500 per quarter to deliver the service for the year as and when required). For example – a treatment room / out of hospital care service would pay circa £1.27 per actual patient per year to provide a number of elements as and when required such as minor trauma/blood samples/ear syringing/dressings etc.
5	Weighted Population Per Item	Similar to 1 but these are based on weighted population.

6	Weighted Population	Weighted population retainer – as per the above but used for a service for a clinical condition that could have more of an impact on patients of a certain age group / deprivation etc. where some practices would see more activity or that would need more time and effort to provide the same service to their patients demographic.
7	Bandings – Static Activity and Static Percentage & Sliding Scale	Bandings can be used by Commissioners for performance related payments. You could use the Static Activity where achievements that meet a certain threshold will determine a higher financial return for the provider. These can be calculated as patients seen or procedures undertaken. Static Percentage shows where performance will be related to percentage complete and based upon them you get a different tariff. The sliding scale is set between 0 and 100 % with every single step up by a percent equals a different tariff amount.

Per Unit - Static Activity

You must enter a minimum of one From / Tariff pair. Each From value should be greater than the last.

There is also a useful calculation tool to help Service Providers work out potential income. Simply enter in the number of patients you have seen or forecast to see and click on the Calculate button.

You will need to select the Banding type required for these scheme.. The example shown above uses the Static Activity. The Static Percentage could be used for a certain cohort of patients. For example, the cohort of your registered patients who are being prescribed Warfarin and are due to have a review – the following would then be payable per percentage of patients who have had their review undertaken.

The sliding scale option is used for both percentages and banding.

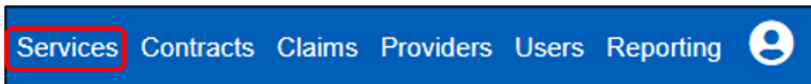

12. A Commissioner Creating a Service

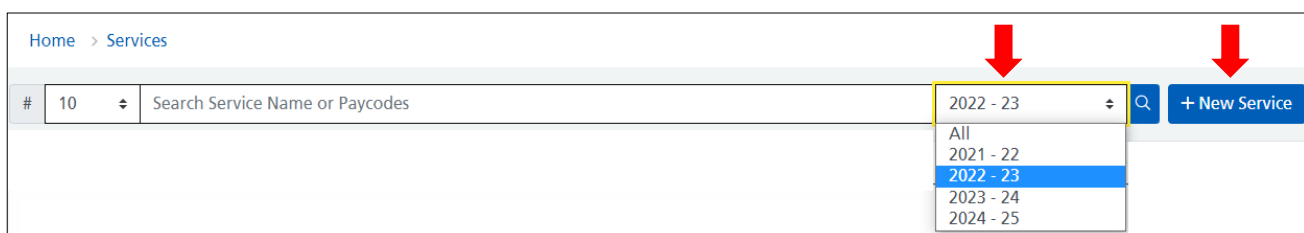
This section will help you understand how to use the system as a Commissioner to create a new service, add components and create contracts. Please note that, due to user permission levels, some of the options you see in this user guide may not necessarily correspond with your live system. If you think you require roles with additional access, please consult with your local Admin User.

Creating a New Service

1. Click on **Services** located in the upper part of your screen or alternatively select the menu tile from your homepage.



2. Select the **Financial Year** this Service will be running in.
3. Next click on **New Service**.



4. You will then be presented with the Service information screen. Below is a screenshot with corresponding letters next to each section to aid you with completing each part correctly.

A message below the description field states: 'No Service Specification Document(s) have been added'.

A. Name - choose a name for the Service – this may, for example be Minor Surgery. A message will appear if you chose a name that is already in use.

B. Financial Year – is the period in which the Service will run.

C. Use PCSE for payments - this will work in exactly the same way as the National System, or simply leave unticked if you have an agreement in place to pay off system.

D. Paycode Description– this will determine which budget this particular service will be paid from. Please choose the most appropriate selection carefully and consult with your Finance Team if in any doubt. The paycodes used will also determine which Service Provider Contract Type they can be used for. The Minor Surgery DES paycodes highlighted below illustrates that these codes are suitable for GMS, APMS and PMS Contracts from their last letter. Minor Surgery DES [DEMSUG, DEMSUA, DEMSUP]

E. Description – any details relating to the service description. You could just enter what the name of the service is.

F. Has Claims Windows – Use this option if you require your Service Providers to submit their claims during a specified period of time.

G. Claims Submitted On Behalf Of Practice By Commissioner - claims submitted on behalf of Practice by Commissioner, this would be an agreed alternative of Service Provider data submission where the Commissioner or a CSU will submit a Claim (s) on behalf of the practice.

H. Service Specification – you may have already emailed this document out to your Service Providers but having the document within the system will make locating it very convenient. We will see how this document is accessible later on in the guide. To upload the document, click on the browse button to locate it. Once you have selected the document, click Open which will automatically attach it.

I. Re-set Form/Save/Next - allows you to clear all the fields you have filled in if you wish to start again, **Save** will enable you to save the form to come back to it at a later time and **Next** will take you to the next page.

5. Enter the **Name** of your service - in this example are service is going to be Minor Surgery.

6. **Financial Year** can remain as it is unless you are adding a service in preparation for a new year.

7. Place a tick in the **Use PCSE for payments** or simply leave unticked if you have an agreement in place to pay off system.

8. **Claims submitted on behalf of Practice by Commissioner** is covered below. For additional guidance, please refer to - [Commissioner Submission on behalf of a Service Provider](#).

9. Choose the **Description** for the Service. This may be the same as the Service Name.

10. **Upload Service Specification Document** – A Service Specification Document is the contract delivery requirement between the Commissioning Organisation and the Service Provider. Click the **browse** button to locate the document on your computer.

11. Once the file has been selected, click the **Open** button.

12. Click on **Next** which is located on the bottom of your screen. This will take you to the Components page.

13. Then click the **Create Component** button.

Adding Components

A Component is an activity that will be undertaken by the Service Provider in conjunction with the Service that they will be providing. For this particular example, Minor Surgery service, our components will be; Excisions, Incisions and Injections.

You will then be presented with the Component screen. Below is a screenshot with corresponding letters next to each section to aid you with completing each part correctly. Please note that if you wish to add several components they would need to be done separately. For example, minor surgery will include 3 components for Service Providers to claim against which are:

- Component 1 – Injection (indicate drug name if required)
- Component 2 – Incision
- Component 3 – Excision

A. Name – This is the name of this particular component. See above for details.

B. Claim Frequency – You can specify when a Service Provider can make a claim for these Components. The frequencies are: Monthly, Quarterly, Bi-Annually or Annually.

C. Tariff Currency – These are: *Per Unit, Retainer, Actual Population Per Item, Actual Population Retainer, Weighted Population per Item and Weighted Population Retainer*. Please see the [tariff currency table](#) below for further clarification as to what these mean.

D. Base Tariff - If you choose, for example, Per Unit for the Tariff Currency and pay a Base Tariff of £10, this will in theory mean that you will pay £10 per patient or per test etc.

E. Description – You can add a little further information here as to what the component is

F. Evidence Required – A Commissioner may request that a Service Provider supplies and uploads evidence to support these claims. The Commissioner will indicate in the grey box what type of evidence is required and the preferred format for this to be produced in. **It is paramount that whenever a piece of evidence is provided it must not contain any information that would identify a patient.** If in doubt please consult with your Caldicott Guardian for further advice.

G. Evidence Required Details – see above

H. Accepted Files – If you request that evidence is provided to support a claim, you can specify which files you will accept.

J. Reset Form & Save -Reset form allows you to clear all the fields you have filled in if you wish to start again, **Save** will enable you to save the form to come back to it at a later time

14. When you have filled in the details of your component, it will look similar to the example below. If you have specified a requirement for evidence, please be clear and descriptive.



It is advisable to copy the Evidence Required information text so that you can paste it into all the proceeding text box fields.

15. When you have completed the form, click **Save**.

16. Your first component has now been successfully added to the system. Should you wish to edit this, click on the **Edit** button. This will allow you to edit the component name, Tariff Currency, the Base Tariff, Claim Frequency as well as the Evidence Required information box. There is also a Delete option if you wish to remove it. Should this be the case, remove it from the system and start back at the Create Components section and start again. For details about the Schedule, refer to section [Schedules \(Claim Windows\)](#).

You can click the **Create Component** button again to add more components to the service. There is no limit as to how many components you can add to a service. Follow exactly the same process as above.

All of the Components have now been entered onto the system. In this scenario we have requested that the Service Provider supplies evidence for each of the 3 components, this means that they will be uploading and submitting the same evidence document 3 times – this will not take long to do.

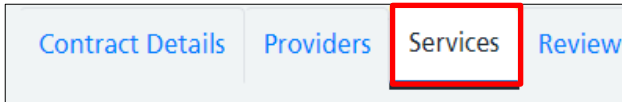

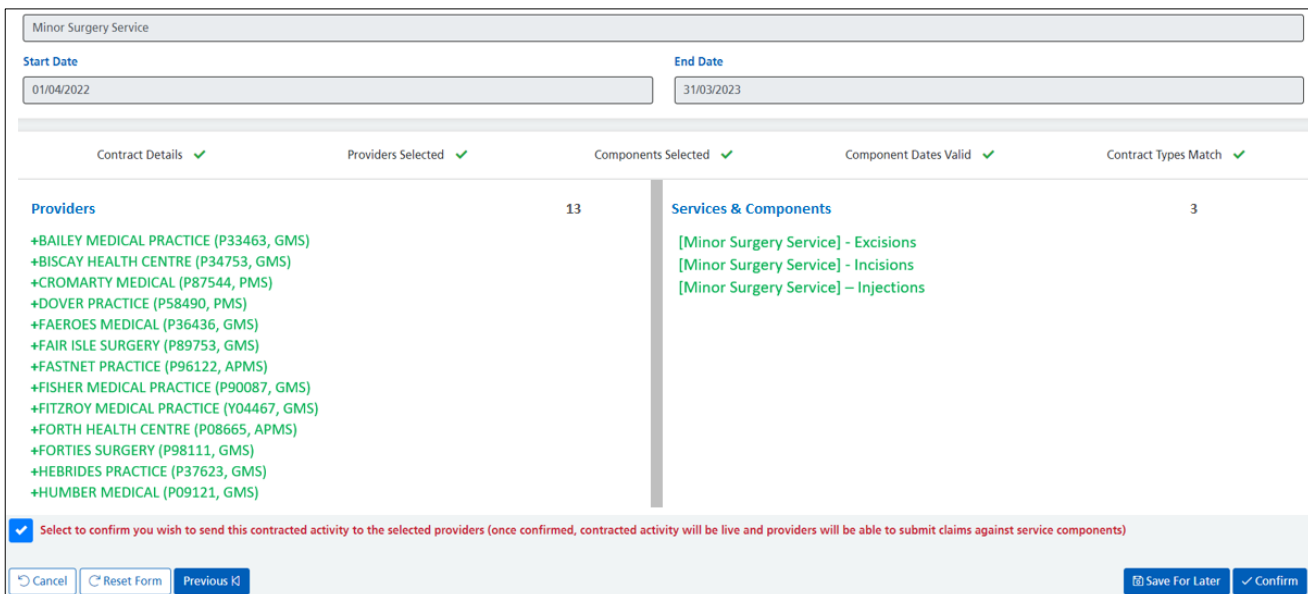

 In this scenario we will be undertaking all actions associated with a two-tier process. It also includes what to do if the claim value exceeds a permitted approval amount.

Tier 1 Approval

1. Firstly, a Commissioning User will need to log in to CQRS Local to proceed with this approval.
2. Click on **Claims** which can be found in the top right-hand corner of the screen or alternatively select the Claims menu tile from your homepage.






3. Your claim will be visible on the claims page. Here will detail the financial rating. The rating categories are as follows:

- **Category 1- Low Risk - Claims with payment of less than £15,000**
- **Category 2- Medium Risk - Claims with payment of £15000 and above but less than £50,000**
- **Category 3- High Risk - Claims with payment of £50,000 and above**

4. The submitted claim will detail; the claim ID, the Provider who submitted the claim, submission date, status and estimated value.

- d) Are you wishing to add any more components to the service?

2. Find your Service and then click on the **View** button.
3. Scroll down to the bottom of the screen and click on the **Clone** button.

23. Re-activating an Expired Claims Window

Re-activating an expired claims window will give the Service Provider the opportunity to submit a claim which has expired.

1. Click on the **Claims** option from the top of the screen.
2. Click on the **Reactivate** button.

3. Enter the number of days you wish to extend the claim window.

The Commissioner will be able to extend the claim by up to 150 days.

The particular example indicates that the claim exceeded the window by 3 days which means that the Commissioner can extend the claim by 21 days, leaving 1 day after this extension. Please follow the guidance on the screen when you undertake this exercise.

4. Click **Save**.

5. The claim will now be automatically re-opened for the Service Provider to submit their achievement.

24. Searching for a Claim using the Claim ID or Name

Searching for a Claim using the Claim ID or Name is a convenient way of locating and keeping track of any particular claim. This might be a query raised by a Service Provider relating to a claim for example.

1. For both Commissioning Organisations and Service Providers click on **Claims** located at the top right hand side of your screen.
2. Enter in your Claim ID or Claim Name and click the magnifying glass.

25. Reporting – By The Commissioner

Reporting is a convenient way to keep an eye on the financial activity per Service and Service Provider for a specific timeframe and a report can be available in just a few clicks. Any CQRS Local user can access these reports.

1. Firstly, click on **Reporting**, located at the top right-hand side of your screen.



2. From there you will see 5 reports. These are:

Each of the sections below will be explained:

Search By:

Created Date (Claim Date) - This is the date the claim was created by the Service Provider

Submission Date - This is the date the claim was submitted by the Service Provider

Activity Date - This is the Activity Window - i.e. 2022-2023 - Month 4

Approval Date - This is the date the claim was Approved by the Commissioner

Search Dates: You can specify the period of time – whether this is the previous month or quarter or any other date parameter.

Services & Components: You can specify any number of services and their components. For example you may wish to run a report on Minor Surgery and its 4 components – *Excisions, Incisions, Injections and Aspirations*.

Displayed Columns: This will allow you to include any of the following headers in your report. *Claim Date, Service, Component, Claim Activity, Claim Tariff and Claim Value*. All 6 are auto-selected by default. If you don't wish to include all of them, simply untick them.

Horizontal Scrolling: Choose how you would like your report to display. There is a button to toggle Yes or No.

Items Per Page: Choose how many items you require per page. This ranges from 20 to 1,000.

5. Click on the **Update** button to display your chosen report criteria. You can use the Export button which will export the report into a CSV output file.

To go back to the reporting page, click on **Reporting** from the upper right hand side of the screen.

6. Select the next report - **Claims Pending For Payment**

This report will allow you to look through all your claims where they are pending for payment. Your report will show you the following statuses:

- Pending First Commissioning Review
- Pending Second Commissioning Review
- First Review Declined
- Second Review Declined

Again, please use the Parameters button to tailor the report to your requirements.

In the first instance it would be ideal for Service Providers to look through claims which are either First or Second Review Declined and to action these and submit for Commissioner Approval. Remember, there will be a reason the claims (s) was declined in the history icon in the claims page.

7. Select the next report - **No Claims Submitted**

This will provide you with information where a Service Provider hasn't submitted any claims for a selected period of time. Service Providers are reminded that even if they haven't undertaken any work for a particular service, they should enter a zero into the Units and submit their claim.

8. Select the next report - **Claimed Services**

This report shows you all the Services that your Service Providers have claimed for and what the status of these claims are. Currently there are the following headers:

- Unsubmitted Claims
- Submitted Claims
- Pending Claims
- Approved Claims
- Rejected Claims
- Expired Claims
- Has Claimed?

The below example shows that for the Minor Surgery Service, 10 have been submitted, 9 of which are Pending (payment) and 1 has been Approved (for payment), none of these have been rejected (declined) or have expired (missed claims window).

9. Select the next report - **Provider Users**

This particular report is useful for Commissioners who wish to view all practice system users and the status of their account. The report includes the following headers:

Organisation Name, Ods Code, Role, First Name, Last Name, Email, Email Confirmed, Approved, Revoked, Revoke Reason, Disabled, Disable Reason.

26. Schedules (Claim Windows)

Claim Windows are set up by default to use the NHS Standard Contract. These dates are configurable and may be amended by the Commissioning Organisation to mirror your current contract (s). The below image displays a monthly schedule. For instances of a quarterly, bi-annual or annual contract the schedule will display the time frames for these periods too.

A. Name – this is the claim year and shows quarters 1 to 4.

B. Activity From – this is the start date of the month you will be claiming from.

C. Activity To – this is the end date of the month you will be claiming to.


D. Claim From – this is the period of time for the start of a claim submission and commissioner approval.

E. Edit – See below.

Changing the Claims Window

As a Commissioner it is your choice whether or not to amend these dates. You may wish to keep dates in-line with your current contractual dates. Amending them is very straight forward and if the editing of these dates is a requirement, this can be done when adding the components when a service is being created. The following instructions will guide you through this.

1. Click on the **Schedule** button.

28. System Statuses

Below are common CQRS Local system statuses and a brief explanation as to their meaning.

Notification Type	Meaning
Service Created	A brand new service has been created. For example, Minor Surgery.
Service Published	The service and components have been added and it is ready to be offered out to Service Providers.
New Contract	The contract is the service and agreement available to a participating Service Provider
Pending Internal Approval	Awaiting Approval from a Provider Approver. This is the status that the Service Provider will see.
Pending System Approval	A claim has been submitted by a SP User to a SP Admin. This is the status that the Service Provider will see.
Pending System Review	If a claim has been submitted with a supporting document, the file (s) will be scanned through an anti-malware check first. The status will change after a minute or two and will display 'Pending First Commissioning Review'.
Pending First Commissioning Review'	The Service Provider has submitted their claim and is waiting for the First Commissioner (tier 1) to approve the claim
Pending Second Commissioning Review	The Service Provider has submitted their claim and is waiting for the Second Commissioner (tier 2) to approve the claim.
Claim Approved	The claim has now been approved for payment by the Commissioner
First Review Declined	Tier 1 Commissioner has declined the claim.
Second Review Declined	Tier 2 Commissioner has declined the claim.
Commissioner Approver Declined	Tier 2 commissioner approver has declined the claim.
Component Nearing End	The claim window for your component (s) is due to expire shortly. A notification will alert you that there is less than 48 hours left to submit the Claim.
Claim Period Expired	The claim window for your component (s) has expired - you will need to process it again next month.
Unclaimed Component	Alert that (service name) has not been claimed. A notification will alert you there is less than 48 hours left to make a claim.
Internally Declined	This is where a Provider Approver has declined a claim.

29. Glossary of Terms

Please find some useful information listed below to help you understand what some of the functionality will do as well as explaining what certain terms and phrases mean.

Term/System Function	Explanation
Tasks & Notifications	A Task is something that requires an action. For example, approving a payment. Notifications are advice/reminders. For example, you will receive a notification if there is less than 48 hours left to make a claim.
Published Date	This is the date that the Service was published (made available for Service Providers) by the Commissioner.
Cost Centre	This is the department at the Commissioning Organisation that finance payments will come from to pay a Service Provider.
Commissioner Submission	Some Commissioning Organisations will ask CSUs to submit claims on behalf of certain Service Providers and this particular function is for use by CSU staff.
Service Provider	A GP practice.
Services	Also known as Schemes. These are local to your area and will depend on which services are on offer. These could be: Wound Care, Cardiovascular health checks, Post-op suture removal, Warfarin prescribing etc.
Bandings	There are 2 banding types - Static Activity and Static Percentage which are usually used for performance related payments. Commissioners could use the Static Activity where achievements that meet a certain threshold will determine a higher financial return for the provider. Static Percentage is when performance will be related to percentage complete and based upon them will return a different tariff amount. A sliding scale can also be used whereby every single step up determines a different tariff amount.
Service Class	These are Local Incentivised Services, Local Enhanced Services, QOF or Other.
Components	The Commissioner adds Components for which a Service Provider can claim against – these can be - incisions, excisions, injections etc.
Provider	The GP practice/Service Provider.
Create New Claim	The Service Provider user would input all the required information in order to make a claim.
Pending Internal Approval	This is at the point where a Service is requiring approval from a Service Provider Approver (Practice or Business Manager).
Claim ID	All claims have a Claim ID which can be referenced at any time or used to search for a particular claim.
Tariff Currency - Actual and Weighted	Age and sex of the patients as well as any in nursing or residential care, additional patient need due to medical conditions, patient turnover and unavoidable costs based upon rurality and staff market forces for the area. This results in an adjusted count of patients known as the “weighted patient count.” (Therefore, ‘actual’ practice population is the number of registered patients with no weighting/adjustment applied.)
Base Tariff	If you choose, for example, Per Unit for the Tariff Currency and pay a Base Tariff of £10, this will in theory will mean that you will pay £10 per patient or per test etc.
Claim Schedule	These are the periods of time set by the Commissioner. These may be monthly payments and therefore 12 months are created in a schedule. The Commissioner would input for example for Month 1 - From 01/04/2020 to 30/04/2020.
Claim Window	The Service Provider will have a certain period of time to submit their claim to the Commissioner and the Commissioner will have a certain period of time to approve the claim.

Contract Basis Code - Confirmed & OptIn	Confirmed means auto confirmed where a provider is automatically confirmed to participate and opt-in is where a practice will have a choice of saying Yes or No. This function will not be used in CQRS Local - For CQRS National only.
Per Unit	Per Unit is coding that persons medical records to claim and then reporting on these numbers for evidence. It could also be referred to as: Per Patient or per test.
Retainer	Retainer is that you will deliver a service no matter how many people you see. A Commissioner may ask for evidence to be provided of tests completed. There may be a certain number for the Commissioner to honour payment. These are usually payable yearly.
Commissioning Organisations	They are responsible for commissioning Quality Services
Quality Services	Quality Services include QOF, DES and V&I but also locally commissioned Quality Services
Commissioner	This will mean your Commissioner or someone from the Commissioning Organisation who deals with your Services, Contracts and Payments
Minimum Viable Product	A minimum viable product (MVP) is a development technique in which a new product or website is developed with sufficient features to satisfy early adopters. The final, complete set of features is only designed and developed after considering feedback from the product's initial users
Contracts	A contract is an arrangement between the Commissioning Organisation and the Service Providers (GP practices).
Claims	This is what the Service Provider is requesting for payment.
Claim Name	This will show you which Service Provider the claim is for and may read something like "Commissioner Claim for Humber Medical Centre".
Bulk Claims	Bulk Claims is a convenient way of undertaking mass claims and can save the Commissioner a lot of time and effort.
Reporting	This functions allows you to generate a report for certain activities. For a Commissioning Organisation you can, for example, run a report on the number of incisions/excisions claimed by one or all Service Providers over a certain timeframe. For a Service Provider you can run a report on the number of claims approved/declined over a certain period of time or instances where a claim window has expired. Reports can then be downloaded to CSV format and electronically filed away.
Claim Frequency	You can specify when a Service Provider can make a claim for these Components. The frequencies are: Monthly, Quarterly, Bi-Annually or Annually.
Evidence Required	A Commissioner may request that a Service Provider supplies and uploads evidence to support these claims. The Commissioner will indicate in the grey box what type of evidence is required and in what preferred format this is to be produced in.
